Why will ISO 50001 be good for your business?


If you are considering reviewing or creating your organisation’s energy strategy, ISO 50001 is a great practical place to start, even if you are not aiming to achieve certification. If you do attain certification however, this will give you automatic compliance with ESOS the next time around.

As far as the ISOs go, 50001 is generally seen by accreditation practitioners as one of the most sensible, straight forward and least onerous to implement.

Well, that’s all very well if you are a practitioner, but what if you are not an expert – either in energy or management processes, is it something that is within your capability to achieve without sleepless nights and lots of overtime? Can you have a serious energy strategy without it?

If this seems like a daunting task, don’t forget, you don’t have to do this all at once. You can use the building blocks of the standard and implement these progressively starting with the areas that give you the biggest return on investment.

Using these building blocks you can put together your own specific 2-3 year plan that suits your business, which should encompass both technical and behavioural projects.




So, having used the building blocks for ISO 50001 and having developed your energy strategy, why bother with accreditation?
